

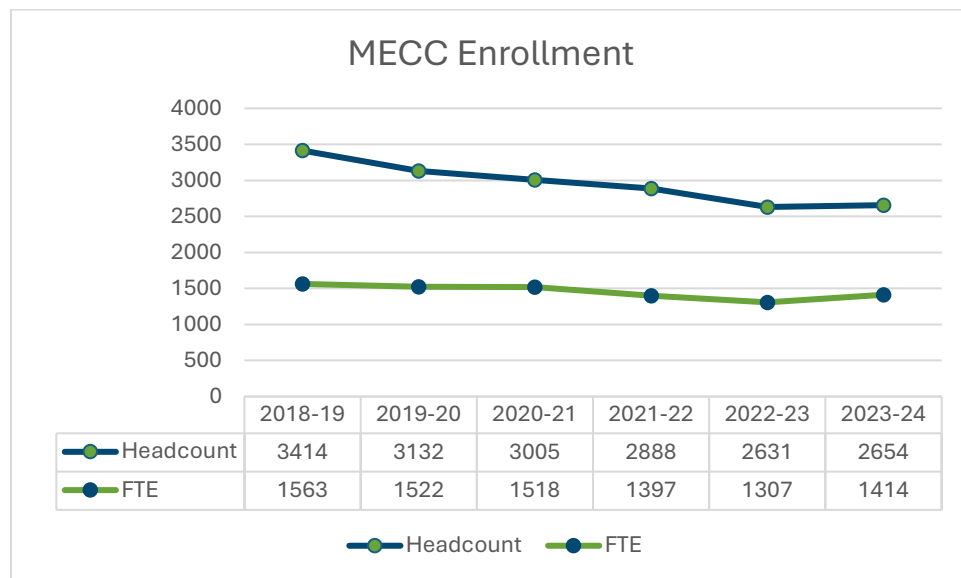
Achievement Goal 1

Conclusion: Before and during COVID-19, MECC maintained more than 1,500 FTEs. Beginning in 2021, fewer high school graduates attended college in our service region (VDOE); however, we are trending upward toward our goal.

Action Plan: We are actively recruiting new and returning students through marketing. We started a Promise Program in 2023 to increase enrollment of recent high-school graduates in our service region.

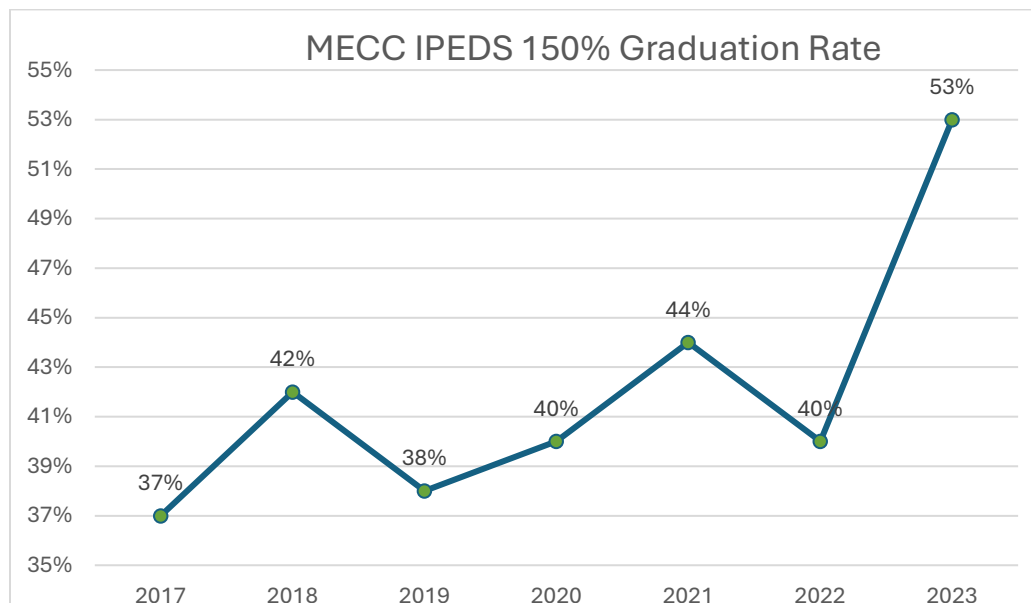
Achievement Goal 2

Conclusion: In 2023, 53% of the students in the 2020 graduating cohort completed a degree within 150% of the normal completion period. This goal is being met.

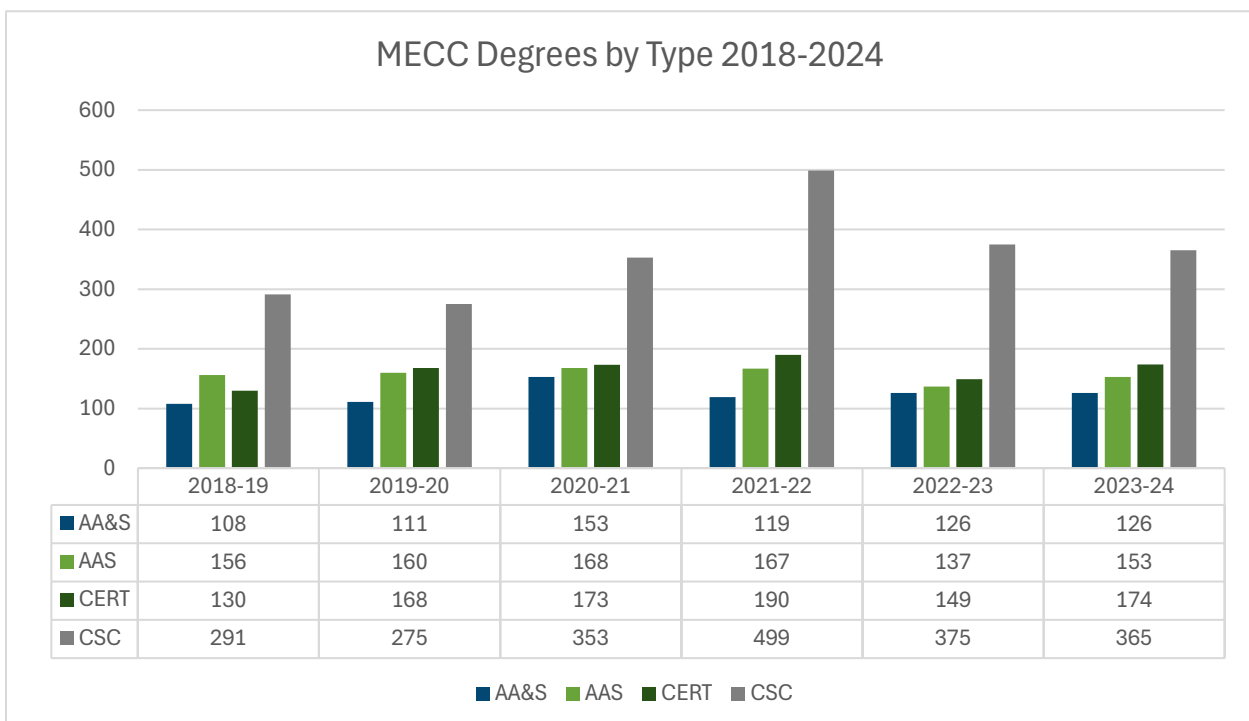
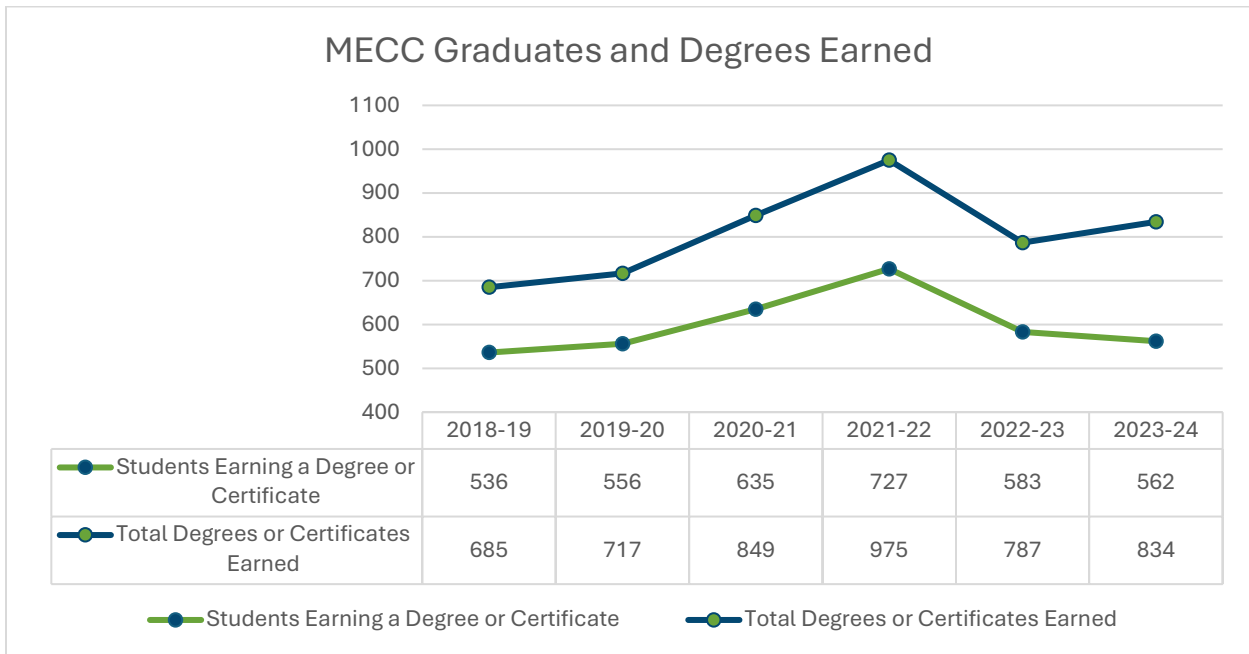
Achievement Goal 3

Mountain Empire measures **student success** as “students who, by the following fall, had graduated from or were still enrolled at Mountain Empire”.

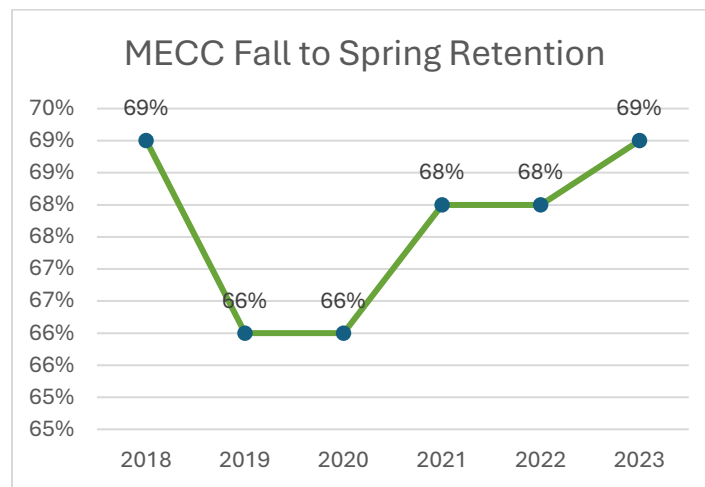
Achievement Goal 5

Action Plan: Academic Advisors are taking extra steps to reach out to unregistered students by helping them overcome obstacles that keep them from enrolling.

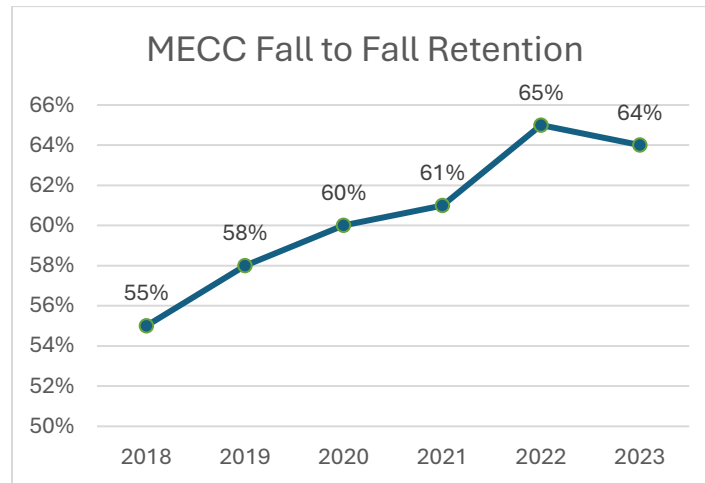
Achievement Goal 6
